2. On the 15th, you wrote a check (number 100) to ABC Insurance Company for your monthly auto insurance premium in the amount of \$150.00. **(Also fill out check below.)**

**VLFCU Teen Contest Rules**

No purchase necessary. **Teenagers who are 13 to 19 years old are eligible if they are a VLFCU member or are an immediate family member of a current VLFCU member whose account is in good standing.** Entries will be accepted from April 1, 2021 through April 30, 2021. In order to be eligible for the drawing, both sides of this form must be completed in full and a correct ending balance must be recorded. Each of the five VLFCU branches will select one winner. Winners will be selected by random drawing of all eligible entry forms. Each winner will receive a \$15.00 deposit into an existing VLFCU account either held by them or an immediate family member. One entry per teen, duplicate entries at other branches will not be included in the drawing. Winners' parents/legal guardians will be contacted on or about May 3, 2021. Winners will have five business days to respond before another winner is selected. Winners' names and photos may be published on various media outlets including, but not limited to, VLFCU's social media accounts and website, newsletters, flyers and print media.
