 - Member may only use SSN for an LLC if it is a single-member business
- Articles of Organization for Domestic LLC Certificate
- o Trade/Fictitious Business Name Registration Certificate (if applicable)
 - For example, the name on the Articles of Organization is Beadwork LLC, if the member wants to be able to cash checks made payable to Beads Galore they would need a Trade Name Registration for Beads Galore that was filed by Beadwork LLC
